President's Report

Lorrie Anthony

It was a good year for the Friends. Book Shop gross earnings increased to over \$100,000; 75 Friends members attended the members-only annual meeting held at the 2 West Bar and Grille; more than 80 library and Book Shop staff attended the holiday party at Gaffney's; and our first library staff membership challenge doubled staff memberships and provided a new refrigerator for the staff room. Additionally, the newly created Fundraising Committee was able to obtain a grant from the Saratoga Arts Community Programs for the anti-bullying video program led by the Youth librarians.

As noted above, the Book Shop continues to grow with an increase in quality merchandise donations, more sales through Amazon (several specialized books sold for over \$400 each) and large volunteer staff of over 80 people. With the increase in staff size and sales, it was determined that stronger policies and procedures were needed to ensure smooth operations. The Book Shop Committee and staff worked throughout the year to develop these. More information is below in the Book Shop report.

The Membership Committee, in collaboration with the Public Relations and Fundraising Committees, have worked hard to increase the visibility of the Friends and to grow membership. To facilitate the essential cooperation between these three committees, we have merged them into one committee dealing with external relations. As such, they all meet at one monthly meeting rather than three separate ones and coordinate their efforts.

The Fundraising Committee organized a number of opportunities for the Friends to raise funds including a book fair and a summer parking lot stint. Especially exciting is the application for and receipt of a grant for \$3,500 for the Youth Services division of the library. Additionally, the committee has been responsible for some fundraising specifically for the library's Saratoga Reads program.

While the successes of this year have made it possible to make a substantial financial contribution to the library this year (\$34,804), they have also allowed us to budget for the 2017-18 year a contribution of over \$50,000.

As I end my term as President of the Friends, I am deeply appreciative of the efforts of the board members and the library director, all of whom have helped make our accomplishments possible. It has been my deep pleasure to work for such a valuable contribution to the Saratoga community as the Saratoga Springs Public Library. Thank you.

Book Shop Committee

Thanks to the excellent work of our management team, fiscal year 2016-17 has been a banner year for the Book Shop. We have seen growth in income, increasing quality of donated materials, significant reorganization of our physical space, and improvement in the management of our wonderful volunteer staff.

The activities of the Book Shop are overseen by the Book Shop Committee, which meets monthly. The committee consists of FSSPL board members, the Book Shop manager and one shop volunteer.

The Book Sop has two part-time employees: Jeff Budge, Manager and Nancy Whalen, Assistant Manager. We acquired 6 new volunteers this year and continue to average around 80 volunteers. The volunteers staff the cash register, shelve and maintain order in the Shop and assist in sorting and pricing donations. We continue, as part of our commitment to community service, to provide job experience to clients of Living Resources and Saratoga Bridges. We currently have 15 volunteers in this category who work in the Book Shop under the supervision of their counselors.

Under the leadership of our manager, a subcommittee of volunteers completed a revision of our volunteer processes. This included new application and interview forms, revised job descriptions, new timesheets and a volunteer code of conduct. In the next year, the committee will review and revise the volunteer job manuals.

Improvements in our physical space continue to be made as necessary and possible. This year the manager revised storage space in the sorting room to accommodate the shelving of our increasing Amazon inventory.

The financial status of the Book Shop continues to be very strong. Total income for this year is estimated to be increased by 10+% compared to last year. There are several factors that contribute to this growth:

- ----minimal increase in pricing in the Shop. Sales increased by 3.4% and continue to be the major source of income.
- ----increase in the use of credit cards which lead to increased income/transaction. Credit cards now represent 25.5% of all shop sales.
- ----our quarterly sales are now 25 cent sales and extend over two days. This has resulted in a 75% increase in sale income.
- ----exponential growth in Amazon sales which have grown by 106% this year.

In summary, the Book Shop is thriving and is proud to be the source of the majority of the funds that FSSPL is able to donate to the library. Our goal is to increase revenue in the next year by 7% and to continue to grow the value of the Book Shop within the library and the entire community.

Finance Committee

Ian Townsend, Treasurer and Chair

Total Book Shop revenue and Fundraising income substantially increased over last year. With these increases in revenue, the Friends were able to contribute \$29,150 to the Library in support of the Children's Summer Reading Program, Saratoga Reads, Staff Development Day, the purchase of a computer space for the handicapped, replacement toys for the Tree House Room, and other miscellaneous programs. Additionally, Ex Libris membership contributions of \$5,654 was given for the purchase of non-fiction books. Along with membership support of local organizations, total community support for the past year totaled \$34,804. The Friends pays annual rent of \$7,200 for the Book Shop space.

Fundraising Committee Carol Godette, Chair

The Fundraising committee, with the help of many board members, raised \$5,968 from four events this year. The first was a June 24 parking event in the Saratogian parking lot netting \$710. In September, Scallions restaurant collaborated with us for a "Friend's Dining Event". They donated 10% of all sales for the evening to the Friends resulting in \$250. In December we hosted a Bookfair at Barnes and Noble. Friends got tips giftwrapping purchases and Barnes and Noble donated a percentage of all sales for the day to the Friends. We netted \$1,508 from event. This April the Friends were awarded a grant of \$3,500 from the Saratoga Arts Council. This grant will be used to fund a children's film making program "How to Unmake a Bully."

Next year we plan to hold a "Dorothy Parker Cocktail Fundraiser" at Hamlet and Ghost in October and have scheduled another bookfair at Barnes and Noble on December 16, 2017.

Partnering with Sue Hamm and the Public Relations Committee, Friends Membership envelopes and Friends information bookmarks were given out at Saratoga Springs Public Library's Concerts in the Park series.

Book Shop Members Only 50% Sales

The Book Shop hosted four Members Only sales in 2016-2017, which greatly boosted awareness of the Friends and garnered new members! A big thank you to all the Shop

volunteers, and to Jeff Budge, manager of the Book Shop, for promoting the membership program.
