2021-2022 President's Report

The past 'year' for the Friends has been exciting, transformative, and by all measures <u>full</u> – so much so that it was 14 months long! After navigating, surviving, and reflecting on the prior, fully COVID year, we began the past year with fresh eyes and new goals.

My overarching priority for my first year as Friends president was to (re)build a solid foundation that would set up our organization for enduring success, while honoring the organization's long history and past traditions. These efforts manifested in nearly every facet of the organization:

Governance

- Financially, the Friends has been able to weather the storm that was COVID quite well, all things considered, and we have taken this opportunity to reinvest in the organization, as is evident in our planned deficit for the 2021–2022 fiscal year.
- The Friends board invested significant time and effort into drafting and enacting policies to ensure our compliance as a 501(c)3 designated organization.
- We also sought to recruit diverse and skilled new members to fill board vacancies and we reinstated the tradition of having student board members. We are thrilled to have two non-voting high school student board members amongst our midst and intend to continue this practice as a means to ensure the perspectives of this group are represented in our decisions and work.
- At the annual meeting, we will be presenting for affirmation by Friends membership the following board members:

Operations

- By adopting a 'gap' fiscal year inclusive of May and June 2022, the Friends shifted its fiscal year so that it now aligns with that of the Library.
- The Friends also implemented a data conversion to shift its electronic communications and data storage from multiple providers to a single location.
- Many other efforts have been made to increase efficiencies of our operations, including financial and administrative policies.

Fundraising Efforts

• The pandemic revealed the risks of relying almost exclusively on a single revenue source. As a result, the Friends have – and continue to – work to diversify our revenue streams, which include retail (in-person and online), memberships, gifts/grants and special events.

- In the Book Shop, our priorities in the past year have been two-pronged. We have worked to attract new and returning customers through targeted sales, such as the Back to School and Community sales open to members and non-members alike. At the same time, we have worked to direct additional resources to support the growth opportunities presented by online sales.
- Efforts to increase and retain membership lead to a high of nearly 300 members during the past year. This figure marks a return to pre-COVID membership and nearly doubles the number of members at the end of the prior fiscal year. Past and future modifications to the membership structure and user experience are aimed at perpetuating this growth.
- After serving as the 501(c)3-designated fiscal sponsor for the inaugural Saratoga Book Festival, the Friends and the Festival organizers agreed to formally adopt the Festival as the Friends' flagship event. This presents numerous opportunities to engage with new audiences, to collaborate with local businesses, and to expand our impact and fulfillment of our mission.

Looking Ahead

- The 2022-2023 fiscal year is already off to an impressive start. Most noteworthy
 of all developments is that the Friends hired its first executive director: Jennifer
 Allen. Jen joined the Friends part-time this past winter and fully stepped into her
 role in July 2022. Taking the step to have a full-time executive staff position
 ensures the Friends are able to achieve its fullest potential in serving the Library
 and our community.
- The current fiscal year also began with a rebranding. We have updated all print signage and collateral, and are working to update electronic materials.
- Additional goals for the coming year include:
 - Increasing Friends membership, including improving the electronic membership experience;
 - Further aligning our efforts and support with the strategic priorities of the Library's leadership and Board of Trustees;
 - Making strides to increase and diversify our revenue sources—a major focus and responsibility of the executive director position; and
 - Updating and standardizing our bylaws in line with current best practices.
- Efforts to achieve these goals are already underway as the Friends was selected as a project partner for the current Leadership Saratoga class!

The Friends is privileged to have an enviable level of support from our volunteers, members, customers, and donors; a steadfast commitment from our staff and my fellow board and committee members; and – perhaps most importantly – incredible partners in the staff of the Saratoga Springs Public Library.

Reflecting on my first term as president and looking to my second, it is my privilege to serve as steward of the Friends. Together, we are bound for great things and I couldn't be more excited for what lies ahead!

Finance Report

The Friends and Book Festival budgeted for a loss for fiscal year May 2021 to April 2022 of (\$53,943), however, with COVID pandemic easing slightly the actual loss was (\$20,113). This deficit reflects the concerted effort of the board to invest in the organization's resources and infrastructure.

The Friends Annual Income was budgeted for \$79,567 with the actual income from online and Book Shop sales totaling \$108,131 or \$28,564 above budget. Expenses were budgeted for \$133,510 with the actual Expenditures at \$128,244.

Book Shop Report

Vinnie Asaro, Book Shop Committee Chair

Since taking over as Book Shop Committee Chair I can report the following – COVID was a difficult time for Book Shop Operations but last year we saw a trend towards recovery. Thanks to the hard work of our Book Shop Manager, Jeff Budge, and his team of dedicated volunteers, we have seen a recovery in revenue toward reaching our pre–COVID numbers. That is primarily due to the development of a successful online program (Amazon and EBay) where sales have been robust. Foot traffic in the bookstore is coming back slowly through the implementation of community and member sales.

The current fiscal year represented a nice recovery from the post-COVID year. Excluding the post-COVID year, the shop exceeded gross revenue of \$100,000 from in-person and on-line sales for the sixth year in a row. The additional two months of operations from the adjustment to align the Friends' fiscal year to that of the Library, \$16,579, brought total revenue to \$117,364.

Membership Report

During the 2021–2022 fiscal year we held a membership campaign to drive awareness and increase memberships. Memberships provide supporters of the Friends various benefits such as discounts in the book shop, special membership events, etc. Although membership numbers dropped during Covid, the Friends attracted lapsed and new members reaching a high of 282 in June of 2021.

For this current fiscal year, we are making strides in providing online membership enrollment options that streamline the process and help with retention. We will also be focusing on more enrollment through campaigns and member outreach.

Public Relations Report

We have settled into a good routine when promoting sales for the book shop. This has been helped by additional signage in the library. Our Facebook page continues to see steady growth and interaction. The community loves our posts about sales and of course about our volunteers. The Facebook page currently has 808 followers.

The Instagram page also continues to grow and interaction is slower than Facebook, but growing with time. We have a number of prominent businesses following us on both platforms that interact with us. Instagram currently has 247 followers. A cool, recent win: author Meg Wolitzer, one of the keynotes for the SBF shared our post announcing her attendance to her 16k followers which gets so many more eyes on the event.

The event listings on the website continue to gain traction and have a good amount of traffic directed towards them, which means people are visiting the site. This could be stronger, but will depend on the direction we want to take with the site as we move forward.

Saratoga Book Festival Report

Ellen Beal, Vice President and Saratoga Book Festival Chair

In the fiscal year 2021–2022, The Friends of the Saratoga Springs Public Library acted as fiscal sponsor for the inaugural Saratoga Springs Book Festival (SBF). In October 2021, the first SBF was held in the Saratoga Springs Public Library, which also served as the Festival headquarters and popup book store. Additional venues were the Saratoga City Center, the Inn at Saratoga, Saratoga Arts Dee Sarno Theater, Caffe Lena, and the Walt and Whitman Brewing Company. More than 500 people attended. In early 2022, the FSSPLFriends Board of Directors and the Saratoga Book Festival's volunteer management team, led by President Ellen Beal, Operations Chair Steve Rosenblum, and Program Chair CJ Purdy, began to explore the possibility of adding the festival to the SSPL portfolio of programs. A vote to operate the festival as a Friends fundraising event was held at the June 2022 Board meeting and was unanimously approved. Plans for the October 21–23, 2022 festival began in early January using transitional branding linking both organizations to the project.

2021 Marie Madden Volunteer Award

The Marie Madden Volunteer Award is presented annually by the Friends of the Saratoga Springs Public Library to recognize those who support reading, learning, and a literate society by offering their volunteer services to the public library.

This award is given in memory of Marie Madden, a dedicated and tireless library volunteer whose good humor, high spirits, and hard work were an inspiration to library workers, library users, library trustees and all true FRIENDS of the Saratoga Springs Public Library and libraries everywhere.

As Program Chair of the Saratoga Book Festival, this year's first honoree, **CJ Purdy**, has worked tirelessly over the past many months to bring an incredible array of authors, poets, illustrators, and interlocutors together in celebration of the written word.

As Operations Chair of the Saratoga Book Festival, the year's second honoree, **Steven Rosenblum**, has deployed his amazing organizational and logistical prowess to secure multiple venues, schedule a vast array of events, and work with multiple partners and contractors to make the festival a resounding success.

We are pleased to honor **Christian "CJ" Purdy** and **Steven Rosenblum** for their dedication to connecting readers and writers together, at the library, and in the entire community.

2021 H. Dunhan Hunt Award

The H. Dunham Hunt Award is presented annually by the Friends of the Saratoga Springs Public Library to recognize outstanding service to the community through support of the public library. It is the highest honor for service to the library.

This award is given in memory of Dr. H. Dunham Hunt who throughout his life was a dedicated and tireless supporter of public library service, and who gave endlessly of his time and talent to create and nurture the Saratoga Springs Public Library from its inception in 1945 to his death in 1982.

As the driving force behind the creation of the Saratoga Book Festival, this year's recipient has helped to enrich the programmatic offerings of the library and of the Friends by tenaciously working to unite a community of people around a celebration of reading and literacy.

Ellen Beal's enthusiasm for the work of the library and for a community project to celebrate literacy is contagious. Her perseverance in creating a festival under the most unlikely circumstances, uniting and leading an ad hoc team through multiple challenges to see the inaugural event to fruition, and helping to find the festival a home with the Friends of the Saratoga Springs Public Library with the aim of ensuring its sustainability are extraordinary. We can think of no better person to be honored with this year's H. Dunham Hunt Award.
